My wife Kathy and I joined 18 other members of the Houston Deaf Senior Citizens for a bus trip to Columbus, Texas. We arrived at the old **Stafford Opera House**, which was built in 1886. It's the largest flat-floored opera house in Texas and houses the Chamber of Commerce.

Then we visited:

- The War Memorial Museum is in a building shaped like a castle tower (it used to be a water tower). The museum contains artifacts from Columbus natives who served in several different wars since the Civil War.
- The Santa Claus Museum includes a vast collection of different Santa Claus items from here and from other countries worldwide.
- The Alley Log Cabin was built in 1836 by Abraham Alley, who served in the Texas Revolution and was one of Columbus's first early American residents.
- The Dilue Rose Harris House was built in 1858. She was best known for her book Reminisces, which is about her family's close acquaintances with several leaders of the Texas Revolution. Her husband, Ira Harris, was once the sheriff of Colorado County for several years.
- **The Colorado County Courthouse** was built in 1891. Visit the second floor to see the District Court Room, where you will see the stunning stained-glass dome in the middle of

Between tours, we went to Schobel's for lunch, where you can choose between ordering from the menu or helping yourself to the daily lunch buffet with a good selection of delicious food and desserts.







Hersey Kiss Cookie Recipe

1 cup unsalted butter room temp
1/2 cup powdered sugar
1 teaspoon vanilla
2 1/4 cups all-purpose flour
1/2 teaspoon salt
32 Hershey Kisses unwrapped
Additional powdered sugar for rolling

- 1. Preheat the oven to 350° F,
- 2. Line two cookie sheets with parchment paper.
- Add the butter, 1/2 cup powdered sugar, and vanilla in a stand mixer. Mix on medium speed until light and fluffy.
- 4. Carefully add flower mixture, 1 cup at a time, to the butter mixture.
- Using a small ice cream scoop, scoop balls of dough.
 Take 1 dough ball at a time and flatten it with your hand. Place a Hersey Kiss chocolate in the center.
 Roll the dough back into a ball.
- 6. Place the rolled Hersey Kiss cookies on the baking sheet, about 2 inches apart.
- 7. Bake cookies for 8-10 minutes until the bottoms become golden brown.
- 8. Remove from the oven and cool for just 5-10 minutes.
- 9. In a small bowl, add your powdered sugar, then roll each cookie in the sugar until coated.
